Day 1: Ship to Shore





Ship to Shore

Start Time = nautical pre-dawn

Day 1 scenario foundation rests on the following sentence: "...BLUE Country carries out nuclear material transport operations, in accordance with its nuclear fuel cycle, which includes the need for maritime transportation for the import of uranium hexafluoride (UF6), which is processed abroad. The UF6 is disembarked at the main port of the BLUE country, in a specific terminal and, later, it travels by road, destined for the fuel cycle plant."







Stimulus Visual Representation of Event Event The MV Barracuda scheduled to dock is making way towards a harbor. The Captain of the ship calls the harbor master to report that they were met at the sea buoy at the scheduled arrival time by a smaller vessel named the Rainbow Warrior. He reports his position at 11 nautical miles from the port but inside the sea buoy. The Rainbow Warrior is conducting unusual and aggressive maneuvers. These actions result in forced changes in speed, heading, and evasive maneuvers to avoid collision. Coast Guard response is requested.

2	Calls to emergency services from port workers indicate a demonstration has begun at the entrance to the port. The demonstration is creating a situation in which day-shift port workers are reluctant to report to work through the picket line, and night-shift workers are reporting difficulty in reaching their vehicles to go home. Law enforcement response is requested.

3	Additional groups of protestors begin arriving by busses, and the swelling crowd of demonstrators. Demonstrators are holding antinuclear signs and slogans. The crowd is growing increasingly agitated.

The city fire department reports that traffic congestion in the vicinity of the port facility will make it impossible for their vehicles to respond to the demonstration in a timely manner. They request that Port Authority fire assets be moved from the port property to the entrance to the facility to render assistance with fire control.

Protestors bearing Anti-Nuclear signs are engaged in acts of violence against nearby business venues, with vandalism, property destruction, and looting. Additional small fires have been set using what appear to be hand-held incendiary devices (Molotov cocktails).





Event Visual Representation of Event Stimulus The Captain of the Cargo Vessel 15 Barracuda reports that administrative entry requirements are completed; and that a preliminary inspection conducted by a nearby tugboat has revealed no damage from the harassment by the Rainbow Warrior.

The local news media station reporting on the situation at the Port announces they have received disturbing images from a representative of the Antarctics. A video claiming to be on board the Barracuda is being live-streamed over social media. The video appear to show a lone person along with palletized cargo in the form of steel pressure cylinders bearing radioactive labels. The person states that he has attached an improvised explosive device to the exterior of one of the tanks and will detonate the explosive unless the nuclear material is turned away from the port.

Day 2: Overland Transport





Overland Transport

Start Time = pre-dawn

Day 2 scenario foundation rests on the following sentence: "...GOLD State is conducting an overland nuclear transport. The nuclear material transported by four (4) trunk trucks is solid uranium dioxide metal. The uranium is enriched to 4% and is bound for a fuel fabrication facility. This enriched material is packed in several drum-style type "B" packages." This is a Category II shipment of nuclear material.

The four (4) trucks are loaded and prepared to depart, along with drivers, co-drivers, and escorts, between the hours of 0400 and 0600 on the morning of the scheduled transport. The Transport Command Center (TCC) is in fact the Integrated Center for National Command & Control (CICC-N) — either acronym works.







Visual Representation of Event Event Stimulus The Site Authority receives notification from the Protective Force elements at the planned point of departure from the facility (Gate 24) that a crowd of protesters has gathered near the gate, and has unfurled a banner and posted signs containing anti-nuclear messages. The protest appears peaceful at this time

5	Reports are received of a large traffic accident involving multiple vehicles and injuries at an intersection 20 Km ahead directly along the planned primary route. Traffic is backing up in both directions as a result of this traffic accident. The convoy proceeds on the alternate route. The alternate route is on a standard 2-lane highway with no concrete median.

6A	TCC receives an emergency communication. An explosion has occurred at the front of the convoy. A vehicle which strangely appeared to have no driver (remote controlled) has collided head-on with the lead escort vehicle and a large explosion occurred simultaneously. This blocks the road and halts the convoy. The lead escort vehicle was destroyed in the collision and resulting explosion, and is currently on fire. All of the occupants of the lead escort vehicle are deceased.

One has been detonated with an incendiary device and the second never went off. The remaining 4 packages are closed and have survived the fire and are intact. Uranium has been burned in the fire and the smoke from this fire contains a low-level plume of contamination

Just before entering the mountains escort elements report that they are switching to text-by-satellite communications. They have reached the pre-established point where radio and mobile phone communications become intermittent in the vicinity of the Sierra Dos Coqueiros mountain range. They anticipate having poor voice communications for approximately 2 hours while the mountains are traversed and the personnel receive food.

Visual Representation of Event Stimulus Event 23 The convoy with escorts and truck #2 have arrived at the pre-planned subsistence stop at Bom Descanso restaurant located at a roadside stop for tourists in a mountainous rocky area. Security perimeter has been established and personnel will eat in shifts. The restaurant manager apologizes that they may be slow because one of their best servers has failed to arrive for her scheduled shift.
